N/A	PFR-1485	Request Scorecards permissions not working correctly.	Previously, if users did not have the Request Scorecards permission, they were not prevented from sending a scorecard request. The Request Scorecards button still displayed on the Team Scorecards screen in the candidate profile. This issue has been corrected.
340578	PFR-4533	Text Area custom field not highlighting when required field is not filled.	Custom fields can be set as required. Previously, when a Text Area custom field type was required, there was no visual indicator when the field was not filled in. This issue has been corrected and the field will be highlighted if there is no value filled in.
340746	PFR-4540	Approval Flow on a Position is not saving the selected approval on newly created positions	A user can select an approval flow for a new position that is not the default approval flow. Previously, if an alternate approval flow was selected, the default approval flow still displayed on the Details page as the selected flow. Note that this was a display issue only and the correct approval flow was in effect for the position. This issue has been corrected and the proper approval flow now displays.

340216	PFR-4559	Bold formatting in emails disappears within the Email/SMS panel on the candidate record	Email templates can have text that is formatted to be bold or italicized. Previously, when an email using such a template was sent to a candidate, the correct formatting was not being displayed on the Candidate details page in the Email/SMS section of the page. This issue has been corrected.
N/A	PFR-4490	Position never appears on Employee Portal if non-default Career Site was selected	When an organization utilizes the Employee Portal, positions posted on a career site should automatically be posted on the Employee Portal. Previously, if a position was posted on a career site that was not the default site, it did not get posted on the Employee Portal. This issue has been corrected.
N/A	PFR-5804	Remove hyperlink from the corporate logo for Employee Portal	Previously, the corporate logo on the Employee Portal had an embedded link that takes candidates only to the default career site. This link has been removed and in future the link will be configurable.
