	PL-6426	Adding a tab on the dashboard allowed HTML	When adding a tab to the Learning Center > Reports > Dashboard tab, the feature allowed someone to enter HTML. This should not be permitted and has been corrected. The tab allows entering of any text in any language.
	PL-6164	Issue with Read-Only questions and exams.	Despite having Read-Only permissions on an exam, an administrator could change the questions assigned to a Random Question Section. This has been corrected, so a user with read-only permissions on the exam cannot make changes to the questions.
	NSD-9109	Error on read-	Previously, there would be an error on

		only permissions on an exam, question pool, and questions.	an exam that was set to read only, with the same permissions on question pool and questions assigned to a random question section. The underlying issue was resolved for those conditions.
350032	NSD-9077	Session attribute value not saving correctly.	When an admin is editing a session and has Read Only permission for a Session Attribute, the WYSIWYG editor is disabled to permit the existing value being retained when the admin saves changes to the module/session.
349756	NSD-9071	Minor vulnerability with the User Profile (resume) fields	A bad actor could edit the entry of another user's User Profile, such as the Education History, Work History, and Language Skills. This has been addressed by ensuring the user record editing the record is the logged in user.
	NSD-9067	Clean up task causing performance issues.	For customers who make extensive use of the data loader functionality, especially using the API versions for transcript data, there can be an impact when the weekly task cleans up records from previous imports. This has been adjusted to reduce the impact on performance.
347432,348068	NSD-9027	Issue with cloned questions and the language bundle version.	Cloned questions were not creating the language bundle(s) version correctly, using 0 instead of 1. This caused problems when taking an exam that used cloned questions. For reference, new questions use 1 as the version for the language bundle(s). The fix corrected cloned questions to start at version 1 for the language bundle(s). NOTE: All questions have at least one language bundle, the primary language of the question.
	NSD-8990	Resolving an issue with database connections remaining open.	A defect was introduced in 2022 that can cause the database connections to remain open related to the user assignments. This has been resolved so the connection closes when it is no longer needed. It is being fixed in

			patches for 22.11, 23.03, and 23.07 as well as in the upcoming 23.11 release.
345786,346953,348811	NSD-8972	Certificate not immediately awarded on completion of courses.	In some cases, users would not see the certificate awarded immediately upon completion. This is because the application would flush the user's cache before the SQL finished updating. The certification would still process eventually. However, the fix has been made to allow the SQL to finish before the cache is updated.
317755,347534,347795,347984,348145	NSD-8964	An error with scheduled reports in 23.07 would cause them to stop running.	This regression was caused by the functionality that added the SFTP Location capability to scheduled reports. The error has been resolved so scheduled reports will run correctly.
347539	NSD-8956	Corrected an issue with database connections being used up.	For some customers, database connections were being used by part of the application that was not terminating the connection when it was completed. This did not affect all customers, but can affect those who have large number of simultaneous connections. The fix is to terminate the connection when it is no longer needed.
347155	NSD-8926	Mandatory evaluations were not marking the course complete	When a module that launches an exam has a mandatory evaluation assigned, it was not automatically marked as complete when the evaluation was submitted. This is now working as expected,
347094	NSD-8924	Minor issue with SSO prevented users from access	It throws Exception while SSO login with empty "GUSER_SESSION", the issue is now fixed.
345118	NSD-8923	Submodule completion when program is market complete	We added a new background process to mark mandatory, not-yet-completed submodules as complete when the program is already complete.
346713,347492	NSD-8905	R201 was not	The R201 report - Course Evaluation

		including all question types.	Summary for Specified Modules/Sessions - will now include all question types.
343374	NSD-8904	Session Enrollment update was not considering enrollment availability.	When an admin wants to use the Session Enrollment update for a program, the enrollment availability set for each module (the "from" dates) will be honored and learners will not be enrolled if the from date has not passed.
345902	NSD-8877	Emails sent from the Catalog Editor were showing all recipients.	Within the catalog editor, there are two features that send emails to all selected participants: the Send Email functions on the Participants screen and on the Indicated Interest list. This caused some privacy concerns, so the functionality has been adjusted to send individual emails to the selected users.
345701	NSD-8863	Question version not incrementing when using the Question Data Loader	When the question workflow is configured to use "Approval mode", the Question Data Loader would not increment the version of a question being updated. This has been changed so the version will increase as long as the version column is either blank or equal to next version number of the question.
341638,349051	NSD-8860	Intermittent EKP error when creating classroom session.	Added some code to correct when the originating session data were incomplete in the in-memory cache.
	NSD-8811	Missing CSRF protection on Learning Modules list screen.	The Bulk Action function on the Learning Modules list screen was missing the CSRF token functionality to protect unsuspecting administrators from being forced to delete a module by an attacker.
	NSD-8810	Withdraw enrollment functionality had a minor vulnerability.	A malicious actor could force one user to withdraw the enrollment of a different from a course by sending the first user a disguised link with the second user's data. This has been changed to ensure the user executing the withdraw command has

			permission to withdraw the second user, as defined by their role in the system.
343628,349581	NSD-8801	Learning Path error caused by multiple enrollments in different languages.	The change will prevent an error from happening on browsing the Learning Path when a user has enrolled in a program multiple times in different language versions.
343427	NSD-8780	Cloned sessions had issues with time zone displays.	The change will prevent time zone conversion against server time and use the time zone configured in the source session instead.
341421	NSD-8715	Certificate not populating names in some circumstances.	Fix to avoid error on printing of Certificates when the certificate has a null attribute ID on a Module Attribute.
345440	NSD-8709	Override on the Enrollment Wizard was not skipping waitlist or enrollment policy.	Override on the Enrollment Wizard will function the same as Group Enroll, enrolling the user regardless of the enrollment policy or waitlist settings.
339227	NSD-8681	Evaluation workflow emails are not sending to users.	Optimized the customized feature of ING to send Grouped Evaluation Workflow Task to learners, similar to how it was optimized on the general feature of the Evaluation Workflow Send Email Task.
332026,341283,343994	NSD-8614	Clean up screen text when failing an exam.	When failing an exam, the text at the end was slightly confusing: "You did not pass the exam this time. Please review the course material and try again. Note that as a result of passing this exam, this learning module has been marked completed!" This has been updated to: to remove the "Note..." string indicating the module was marked completed.
333015	NSD-8505	Issue with programs and multiple enrollments.	Fixed the program completion logic to mark program as completed if the program is enrolled multiple times in the same day and one of them has

			fulfilled the required module completion(s) or exam completion.
	NSD-8391	Parent Question Pool permissions allowed access to children	Added a new System Configuration "Question Pool Permission Inheritance".When enabled, if a user has unrestricted permission of parent question pool, then user is able to add/edit/delete questions in child pool(s).When not enabled: Permissions on child pools must be explicitly set to allow access. If permission is set on a lower level, but not on a higher level, the user will still need to set permission for the higher level to allow access to the lower level question pool. The said System Configuration is applied on pages related to the question like Questions List page, Question Editor, etc.
