358271	PFTMP-3413	Secondary Data Source Field Values do not Appear in Chart	Previously, values that were stored in a secondary data source field did not appear in the chart profile or advanced search areas. This issue has been corrected. Secondary field values will not display in these areas.
355635	PFTMP-3407	Numeric Column Format Issue for Exported Search Results	Previously, when search results were exported to Excel, values in numeric format columns were preceded by a "0".For example, the value "1.00" would be displayed as "01.00".This issue has been corrected.
355053	PFTMP-3404	Charts with Large Photos causes PDF/PPT Exports to Hang	Previously, when exporting a chart to PDF or PPT, the system would hang if there were too many large photos included in the export.Instead of timing out, the system would stall and and a "Processing" message would remain.As this release, the system will now time out.Note: We

			recommend photos that are no bigger than 100kb to help prevent this issue from happening.

354397	PFTMP-3401	Sort Order Changes when "Direct Reports" View is Selected in a Chart Box	Previously, the sort order of people in a chart box would change when "Direct Report" view was selected for the box. This issue has been corrected and the sort order will remain the same in "Direct Report" view.
351955	PFTMP-3353	"Also Reports to" Function Displays Incorrect Managers for Indirect Reports	Previously, in a data set where multiple records shared the same BoxID, the "Also reports to" function would select the first record in the CSV file instead of the correct record(s) for an indirect report. This issue has been corrected and this function will now display all managers for an indirect report.
350007,352839,363776	PFTMP-3344	Filters Not Available in Planning Charts	Prior to Version 23, customers were able to filter Planning charts. This functionality has been restored in this release. Note that when a filter is applied, all planning functions will be disabled until the filter is cleared.
	PFTMP-3341	Graphs not Breaking Down Fields Properly	Previously, graph counts were not always broken down properly. This issue has been corrected.
345426	PFTMP-3332	Chart Boxes Disregarding Job ID	When multiple people share the same chart box, they should be grouped by Job ID, with Job IDs displaying in sequential order. Previously, people sharing a chart box were instead grouped by Job Title, which also meant that the groups were not displayed in sequential order. This issue has been corrected and the boxes are now grouped by Job ID in sequence.
345240	PFTMP-3331	Encryption Functionality Incompatible with FIPS	Encryption method updated to meet FIPs requirements.
343362,345426,363070	PFTMP-3322	Direct Reports View does Not Display in PDF or PPT Exports	Previously, when an HTML chart was set to "Direct Report" view and then exported to PDF or PPT, the orginal chart view displayed in the export instead of the only direct reports. This issue has been corrected.
341854	PFTMP-3319	Priority Value not Editable for All	Previously, the priority value was not editable for all position types. This resulted in not being able

		Position Types	to set the priority for some types, such as Open Position. This issue has been corrected and the priority value can be set for all position types.
338571	PFTMP-3308	View Profile Icon Replaced in Planning Chart	Users will notice that the previous "View Profile" icon (lightning bolt) has been replaced with a shilouette icon.
338571	PFTMP-3307	Issues with Popup Screens in Planning Charts	Previously, there would randomly be issues with popup screens in Planning Charts. For example, sometimes, when hovering over a box, the popup would not display. In this release, these issues have been corrected.
337784	PFTMP-3287	Verifying an Email Address Sets to Chart Status to "Modified".	Previously, if a test email was entered and verified in a chart, the chart status was set to "Modified" even though no changes had been made to the chart. This issue has been corrected. The chart status is no longer updated when an email is verified.

330426	PFTMP-3259	Sort Option not Available in all Lists	The sort option has been added to the chart list, data source list and instance list.

326794,330318,339086	PFTMP-3248	Indirect Record Type Value Displays Incorrectly in Record Type Field in Base Fields Display	Previously, Indirect record types were displayed incorrectly in the Record Type Field in the Base Fields display. Where customers were expecting the record type to be "I", it would be displayed as "E" or some other value. This issue has been corrected.
322897	PFTMP-3245	Drilling Down in Hierarchy/Preview Takes User back to the Home Page	Previously, choosing a drill-down opton in Hierarchy/Preview Mode would sometimes take the user back to the Home page. This issue has been corrected.
320427	PFTMP-3222	Hierarchy/Preview does not match HTML5 Chart Output	Previously, when expanding a person's name in Preview mode, there were content mismatches between the preview and the actual ouput. This issue has been corrected.

313436,322469	PFTMP-3006	Spotlight Feature Reveals Filtered Records if there is More than One Person in the Box	Previously, activating the Spotlight feature would display filtered records if there was more than one person in the box. This issue has been corrected.
264257	PFTMP-769	Photo Blocking Users from Accessing Hotspot in HTML5 Charts	Previously, a photo would block the hotspot, preventing the user from accessing this.To mitigate the issue, the photo has been added as a click target for hotspots.
262262	PFTMP-699	HTML Chart Displays a Period after the Employee Name	Previously, the HTML chart would display a period after the employee name, even when not configured to do so. As of this release, the period is removed unless it is included in the employee name.
