	NSD-7691	Adding external URLs to the navigation causes two windows/tabs to open in some cases	New UI pages are broken when the signed in user doesn't have permission to access any configured External Link for the skin's navigation menu set. Secondly, if the navigation menu set contains any External Link that is meant to be opened in a new tab, the click action could open two tabs at the same time for some browsers on the new UI page. These issues have been fixed.
313712	NSD-7938	Users enrolled on revision 0 despite the effective revision being 1 when the enrollments were created	There could be an edge case scenario that an older revision could be enrolled for some users even if a newer revision has been published due to concurrency issues. Preventive measures have been added to avoid this problem.
327320	NSD-8253	Fixed Resource Planner issue that prevented loading Instructor availability.	If there's empty start or end date scheduled for a saved session or a session set up in cache associated to the instructor being looked at in the Resource Planner, there would be an error rendering the event. This has been fixed.
327579	NSD-8296	Time zone not displaying in Session Transfer	Time zone is now properly displayed in Session Transfer.
329957,336976,340257	NSD-8306	Problems with images in Catalog Editor, Drag & Drop questions, or user biography.	In a number of hosted environments, customers were experiencing errors upon 1. updating the course image in the Catalog Editor, 2. updating images in a Drag & Drop question and 3. updating bio images. Customers in hosted environments should no longer experience these errors.

338275	NSD-8557	Added GDPR Protection on User Group creation and editing.	The Organization field will be required when creating or editing a user group going forward. Prior to this change when a user with a role set up to limit visibility to the user's organization created a user group with a criteria other than Organization (such as Join Date), that user could view other users outside of the organization limit when assigned under the Supervises tab. Since the user is limited, when editing or creating a user group, even with other criteria (such as Join Date), the user visibility limit will be enforced.
338409	NSD-8559	Allow parsing of SCORM interaction dates and times that don't conform to the ISO standard.	Allow parsing of SCORM interaction dates and times that don't conform to the ISO standard. Previously, when a course submitted a timestamp without the timezone offset, it would result in a WARN message in the log and the timestamp would be skipped. With a lot of users taking this course, the log could fill up with these warnings. After the fix, the timestamp will be parsed and no warning message is entered.
338428	NSD-8562	Corrected minor issue with courses created with the Courseware Editor in the application.	Corrected minor issue with courses created with the Courseware Editor in the application.
338308,339126,339769,340340	NSD-8580	Fixed minor issue when bad data in the Reference Resources ordering causes issue with saving modules.	In some cases, the ordering field for Reference Resources would cause duplicate values. This caused problems saving the module. A minor change was made that will ignore duplicate values and allow the course to be saved.
338979	NSD-8589	Competency processing for classroom courses without a transcript end/completion date.	Classroom training record can be created without any end date via Turbo Training HIstory CSV loader or other means which would cause background task to fail if the record is a substitute course for some target training that is associated with a competency. This has been fixed.

338321	NSD-8604	Removed the addition of session start and end dates from OJT modules.	When the setting "In catalog editor, show start date and end date fields for online modules" is enabled and transcript records for users on On-the-Job Training modules were added with start and end dates, those dates would populate the field in the catalog editor. This would cause anyone marked as completed via the Catalog Editor, to have the most recent end date as their end date, rather than the current date. This has been fixed to prevent the data loader from populating the session start and end dates.
