# About Rustici Engine Multi-Database Configuration

This is a companion document to the Rustici Engine Installation Guide. It describes how to configure Rustici Engine to use a different database for each tenant in a multi-tenant implementation. Rustici Engine is PeopleFluent's solution for launching and tracking SCORM and AICC courses with PeopleFluent Learning.

## Audience

This document is intended for PeopleFluent's partner companies, who wish to install Rustici Engine on separate databases in a multi-tenant implementation.

This document assumes that you are familiar with the supported operating systems, database servers, web browsers, and network configuration.

## Configuration Process Summary

You can configure Rustici Engine to use a different database for each tenant in a multi-tenant implementation. The configuration steps for each tenant are as follows:

1. Create the tenant database and credentials.
2. Build the database connection string.
3. Create the tenant in Rustici Engine.
4. Configure the tenant.
5. Install tables for tenant database.
6. Test the tenant's credentials.
7. Update `ekp.properties`.

## Create the Tenant Database and Credentials

Before installing Rustici Engine, you must create its database and an admin user.

For example, to prepare a SQL Server database:

1. In SQL Server Management Studio, create a new database named rustici.
2. Create a new login named rusticiadmin with SQL Server authentication and non-expiring password.
3. Set the database role membership for the rusticiadmin user to db\_owner:
  - a. In the Object Explorer, expand rustici > Security > Users.
  - b. Right-click rusticiadmin and select Properties from the context menu.
  - c. In the Membership page, select the db\_owner check box.

## Build the Database Connection String

The connection string depends on the database type. Example connection strings for SQL Server and MySQL are shown below.

### SQL Server

```
jdbc:sqlserver://  
EngineHost;TenantDBName=rustici;user=TenantDBUser;password=TenantDBUserPassword|  
com.microsoft.sqlserver.jdbc.SQLServerDriver
```

### MySQL

```
jdbc:mysql://EngineHost/TenantDBName?  
user=TenantDBUser&password=TenantDBUserPassword|com.mysql.jdbc.Driver
```

You must use the Rustici Engine API to create the tenant in Rustici Engine.

- Base URL: EngineHost/api/v2/
- API: appManagement/tenants/{tenantName}

Send a PUT request with the body:

```
{"active": true}
```

Rustici Engine uses Basic authentication in the header, with the ApiBasicSystemAccounts property in the RusticiEngineSettings.properties file 'username:password' base-64 encoded:

```
BASIC dXN1cm5hbWU6cGFzc3dvcmQ=
```

A successful request returns a 204 response.

## Configure the Tenant

Using the API, add the database configuration information to the tenant:

- Base URL: EngineHost/api/v2/
- API: appManagement/configuration

Send a POST request with the body:

```
{
  "settings": [
    {
      "settingId": "TenantDatabaseConnectionString",
      "value": "{DatabaseConnectionString}"
    }
  ]
}
```

Where the DatabaseConnectionString comes from the earlier step.

Rustici Engine uses Basic authentication in the header, with the ApiBasicSystemAccounts property in the RusticiEngineSettings.properties file "username:password" base-64 encoded:

```
BASIC dXN1cm5hbWU6cGFzc3dvcmQ=
```

Send this additional header:

```
engineTenantName: "{tenantName}"
```

A successful request returns a 204 response.

## Install Tables for Tenant Database

To install the tables, run this command line on the server:

```
java -Dlogback.configurationFile=logback.xml -cp "lib/*"  
RusticiSoftware.ScormContentPlayer.Logic.Upgrade.ConsoleApp <persistenceEngine>  
<systemDatabaseConnectionString> <tenantDatabaseConnectionString> [schemaPrefix]  
<tenantName> -tenant
```

Where:

- <persistenceEngine> is the name of your DBMS. The value should be either sqlserver, mysql, oracle, or postgresql.
- <systemDatabaseConnectionString> is the connection string for your system database.
- <tenantDatabaseConnectionString> is the connection string for the new tenant database.
- [schemaPrefix] is the name of the schema that Engine's tables should be created in. This value is optional. If not included, Engine will use the default schema for the user provided in <systemDatabaseConnectionString>.
- <tenantName> is the name of the tenant for this database. It should be unique, and is required.



## Test the Tenant's Credentials

Use the Rustici Engine API to test the credentials:

- Base URL: EngineHost/api/v2/
- API: courses
- Query String Parameters:
  - ?includeRegistrationCount=true
  - &includeCourseMetadata=false

Send a GET request with no body.

Engine uses Basic authentication in the header, with the ApiBasicSystemAccounts property in the RusticiEngineSettings.properties file "username:password" base-64 encoded:

```
BASIC dXN1cm5hbWU6cGFzc3dvcmQ=
```

Send this additional header:

```
engineTenantName: "{tenantName}"
```

A successful request returns a 200 response.

## Update ekp.properties

Follow the guidance to update the ekp.properties file with the following properties:

- rustici.uri=*URL for the Engine*
- rustici.username=*ApiBasicAccounts username*
- rustici.password=*ApiBasicAccounts password*
- rustici.enginetenantname={*tenantName*}
- rustici.importdefault=true
