Issue ID	Internal ID	Description
319106	PFTMP-3218	Previously, new users could not be created utilizing an email address with a top-level domain longer than three characters. For example, if the email address had a domain of .info, it would not be accepted as a valid email address. In this release, the maximum length of the top-level domain has been expanded from three to 63 to accommodate longer domains.
319263 319686 327105 328750	PFTMP-3220	Previously, there was an issue with archiving migrated charts. When attempting to save the configuration for chart archiving, an error message was displayed. This issue has been corrected in this release and migrated charts can now be archived.
320659 341165	PFTMP-3223	Previously, there was an issue where the Planning chart would display field names instead of field labels in the Profile View. This issue has been corrected and the field labels will now display in this view.

323737 329284	PFTMP-3233	Organizations have the ability to set a default view for a chart and, in some cases, that view may not be accessible to all users. Previously, if a user opened a chart with a default view to which they did not have access, the chart did not display and the user would only see a blank screen. In this release, the system has been updated to display a message to the user when no views are available to them.
338036	PFTMP-3288	Previously, PDF, PowerPoint and Capture View exports from "Chain of Command" mode did not contain the entire chain of command, but would stop at the immediate manager/supervisor. This has been corrected and exports now contain the entire chain of command.
332000	PFTMP-3301	As of this release, a date/timestamp will be sent to the browser when a Planning chart is created.
338571 339499 351657	PFTMP-3304	Previously, first and middle names could not be added to Charts and Planning Charts as they were not available. Only last names were listed. As of this release, first and middle names will be included in the Profile and will be sorted according to the profile config.
340540	PFTMP-3306	Previously, the OrgPublisher/iPaas sync did not update the External ID in the iPaas system. This issue has been corrected as of this release.
341148	PFTMP-3309	Previously, when accessing a secured chart with an email notification enabled, changes made in the Security menu would cause an error message "Chart Contains Invalid Data" if the email did not connect. This issue has been corrected in this release and this error is no longer displayed.
341224	PFTMP-3313	In this release, we have corrected issues with the French "As of" date on charts, where the month did not display correctly when a user's default language is set to French.

349834	PFTMP-3340	Previously, when attempting to sort by Job Sequence Number, the system would ignore the Job Sequence Number if it was greater than nine digits and sort by Position Sequence instead. This issue has been corrected.
349478	PFTMP-3348	Previously, filtering on multiple position types returned no records. In this release, this issue has been corrected so filtering on multiple position types works properly.
