# Hardware and Software Requirements

The following sections describe system requirements and information about setting up your server for use with PeopleFluent OrgPublisher Charting web apps.

## **Application Server Requirements**

#### Administration and Charting Web App Requirements

To use the PeopleFluent OrgPublisher Administration and Charting web apps, users need a supported web browser with JavaScript enabled and the URL of both web apps added to the web browser's Trusted Sites. For more information on how to configure these options, see your web browser's documentation.

As an alternative to adding a trusted site, Microsoft Internet Explorer users have the option of instead enabling Active Scripting. For more information, see that web browser's documentation.

### **Database Requirements**

#### **Data Sources**

To use a database as a data source for charts, you must use a SQL database with its supported ODBC driver installed on the PeopleFluent OrgPublisher application server.

Note: Oracle ODBC connections require a 64-bit Oracle driver.

#### What-If Planning

To use What-If Planning in charts, you must have the following:

- PostgreSQL 10.0 or later.
- A valid connection to a PostgreSQL database.

## Web Browser Support Policy

To provide the best security and performance for our users, PeopleFluent recommends that clients use one of the following browsers to access PeopleFluent applications.

Unsupported older browser versions may have rendering or compatibility issues. When such issues are reported, PeopleFluent will attempt to recreate on fully-supported browser versions and, in the event this cannot be replicated, the remedy will likely be a recommendation for clients to upgrade to a supported browser.

### Microsoft Edge (latest stable release)

PeopleFluent requires the latest patches be installed for all supported web browser versions. The following are known issues or limitations of web browsers that may affect the PeopleFluent OrgPublisher Administration and Charting web apps:

- The PeopleFluent OrgPublisher Charting web app does not support printing from the web browser. Instead, PeopleFluent recommends using the Charting web app's PDF or PowerPoint export features, then printing from those applications.
- The PeopleFluent OrgPublisher Administration and Charting web apps do not support using Compatibility or Enterprise mode with any version of Microsoft Internet Explorer.

#### **Internet Access**

The PeopleFluent OrgPublisher Administration and Charting web apps require access to www.gstatic.com to render graphs.
