Common	354013	PTMSD-3722	The Roles column in SmartGrids does not save the filter 'Does Not Contain' when modifying a grid view. This has been resolved, but existing views must be saved again after upgrading in order to save the operator value.
Common	Internally found.	PTMSD-3727	The EEH file is not updating with clearcollection=0 if there is only the current employment history in both the existing and incoming records.
Compensation	349619	PTMSD-3586	Option to send as offline report is not available when the 'Export Import Worksheet Max Rows' setting was increased.
Compensation	Internally found.	PTMSD-3615	Off-Cycle form drop-down list does not set field to blank when a blank value is selected.

Compensation	Internally found.	PTMSD-3729	Able to write a Row Level formula for the sigKey field, but it is not available under the Column Manager to move its position.
Compensation	Internally found.	PTMSD-3816	User Select List inconsistent behavior on worksheet. If there are special characters in the drop-down list values, the drop-down list does not open on a single click; user must click twice to open the drop-down list.
