| Common | 360380 | PTMSD-3937 | Cannot schedule report when additional grid filtering is enabled. |

| Common | Internally found. | PTMSD-3963 | Validation failing in iPaaS configuration page. |
| Compensation | Internally found. | PTMSD-3834 | Two process log error messages need Employee ID (not just employee name) to properly troubleshoot problems. |
| Compensation | Internally found. | PTMSD-3879 | Pregenerated statements are not working from the My Compensation Statements dashboard widget after upgrade to 24.04. |
