	PLC-647	Job Profile Competency Quota Analysis issue	When revoking a competency via the Job Profile Competency Quota Analysis feature, the proficiency level was not pre-populated.This is fixed now so the existing proficiency level will populate the details UI for the revocation.
	PLC-646	Job Profile Competency Quota Analysis issue	The Job Profile Competency Quota Analysis feature was incorrectly showing Revoked for users who had no history.This will now show the correct status.
	PLC-634	Minor UI Change for Deleted Certifications	The header for Deleted Certifications had the wrong column title Date for Date Deleted.
	PLC-612	Certification History Data Loader issue	When a Deleted event was added via the Certification History Data Loader, the certification was still showing as active on the Certifications page.This has been corrected to show on the Deleted Certification tabs.
	PLC-607	Certification History Data Loader permission issue	Users with No Access or Read Only for the Certification History could add a history record via the Certification History Data Loader.This has been fixed to require Unlimited access.
	PL-8642	Program Session Selection Issue	There was a minor defect when a Learner wanted to select a session of a program with more than one sessions.This has been corrected, and the user should be enrolled in the appropriate modules for the selected session.

A few of them were not working correctly when the user had selected an interface language other than English -- including French, German, and Dutch. These have been corrected.
369411	NSD-9753	Reset Password Page issue	The Reset Password Page was not properly translating when the user clicked the reset password link. Since the user is known, the system will now look up the user's selected language and display a translated page.
367470,372939,372940	NSD-9843	System Transfer email issues	In 24.04, a new feature was added to provide 'cancellation' notification when a user transfers from one session to another to remove the meeting invitation for the original session. This caused issues when there was no date/time for the original session. With this fix, the cancellation notification will not be sent if there is no date in the original session.
